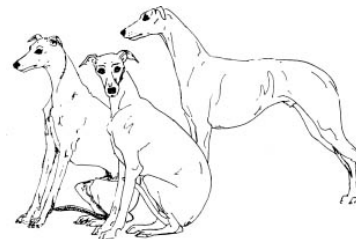

STAKES OFFERED:

"It is recommended that Junior Courser hounds entering the open stake for the first time have successful coursing practice with other hounds before competing."

OPEN: Open to all hounds that have attained at least one of the following: AKC Junior Courser, ASFA Field Champion title, or CKC Field Champion title. Hounds that are disqualified from AKC, ASFA, or CKC field trials may not be entered. OPEN VETERANS: Open to all hounds which are eligible to enter open or specials stake and meet the age requirement for veteran, as established by their breed club. SPECIALS: Open to all hounds that are eligible to enter the Open Stake and have earned their AKC Field Champion title.

BEST IN FIELD WILL BE OFFERED. Note: Italian Greyhounds are not eligible for BIF, GENERAL INFORMATION:

Each entry will be examined at inspection for breed disqualifications. Bitches in season and lame hounds will be excused. Entry fees of hounds deemed lame or in season at roll call will be refunded. Hounds not present at roll call will be scratched after a 5 minute grace period. Spayed and neutered hounds, without breed disqualifications, may be entered. Battery powered, continuous loop lure machines will be used. The lure will consist of white plastic strips. Backup equipment will be available. The Field Committee reserves the right to bar known aggressive dogs from the trial site. NCWFA reserves the right to alter the course plan as required by weather and/or field conditions on the day of the test. **A penalty of \$5.00 will be assessed for any loose hound not competing in the course in progress.**

PICK UP AFTER YOUR DOG! Violators will be subject to a bench hearing. Help us to keep this wonderful site available.

Please bring your own shade and water. Bring a lunch item and join us for our potluck at the lunch break.

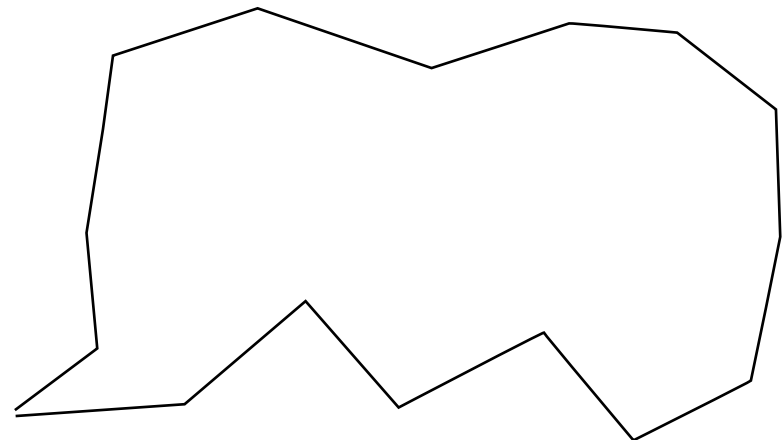
Porta-potties will be available.
