### STAKES OFFERED

**\*\* Any hound that does not have a prior qualifying score must first obtain a Qualified Courser title. Dogs that obtain QC at event will be able to enter the event at the Day-Of Entry Fee. \*\***

**OPEN:** Open to all hounds that have attained at least one of the following: AKC Qualified Courser, ASFA Field Champion title, ASFA Pre-Cert, or CKC Field Champion title. Hounds that are disqualified from AKC, ASFA, or CKC field trials may not be entered. **OPEN VETERANS:** Open to all hounds which are eligible to enter open or specials stake and meet the age requirement for veteran, as established by their breed club. **SPECIALS:** Open to all hounds that have earned their AKC Field Champion title. **SINGLE:** Open to all hounds, including those disqualified to run in other stakes.

### GENERAL INFORMATION

#### EARLY ENTRY FEES AND PAYMENTS

MAIL ENTRIES to the Field Secretary's address above and make checks payable to "NCWFA". FAX ENTRIES will not be accepted. E-MAIL ENTRIES will be accepted provided the Field Secretary receives payment before 7:00 pm on Wednesday, January 10, 2024 and the entry form is signed. **Qualified Course Handlers:** Please make arrangements to have a test dog for your QC. Test dog will be required to fill out an entry form.

Each entry will be examined at inspection for breed disqualifications. Bitches in season and lame hounds will be excused and entry fees refunded. Hounds not present at roll call will be scratched after a 5-minute grace period. Spayed and neutered hounds, without breed disqualifications, may be entered. Battery powered, continuous loop lure machines, and white plastic lure will be used. Backup equipment will be available. The Field Committee reserves the right to bar known aggressive dogs from the trial site. NCWFA reserves the right to alter the course plan as required by weather and/or field conditions on the day of the test. **A penalty of \$5.00 will be assessed for any loose hound not competing in the course in progress.**

**PICK UP AFTER YOUR DOG!** Violators will be subject to a bench hearing and/or fine. Help us to keep this wonderful site available.

**POTLUCK LUNCH:** Bring a lunch item and join us for our potluck at the lunch break.

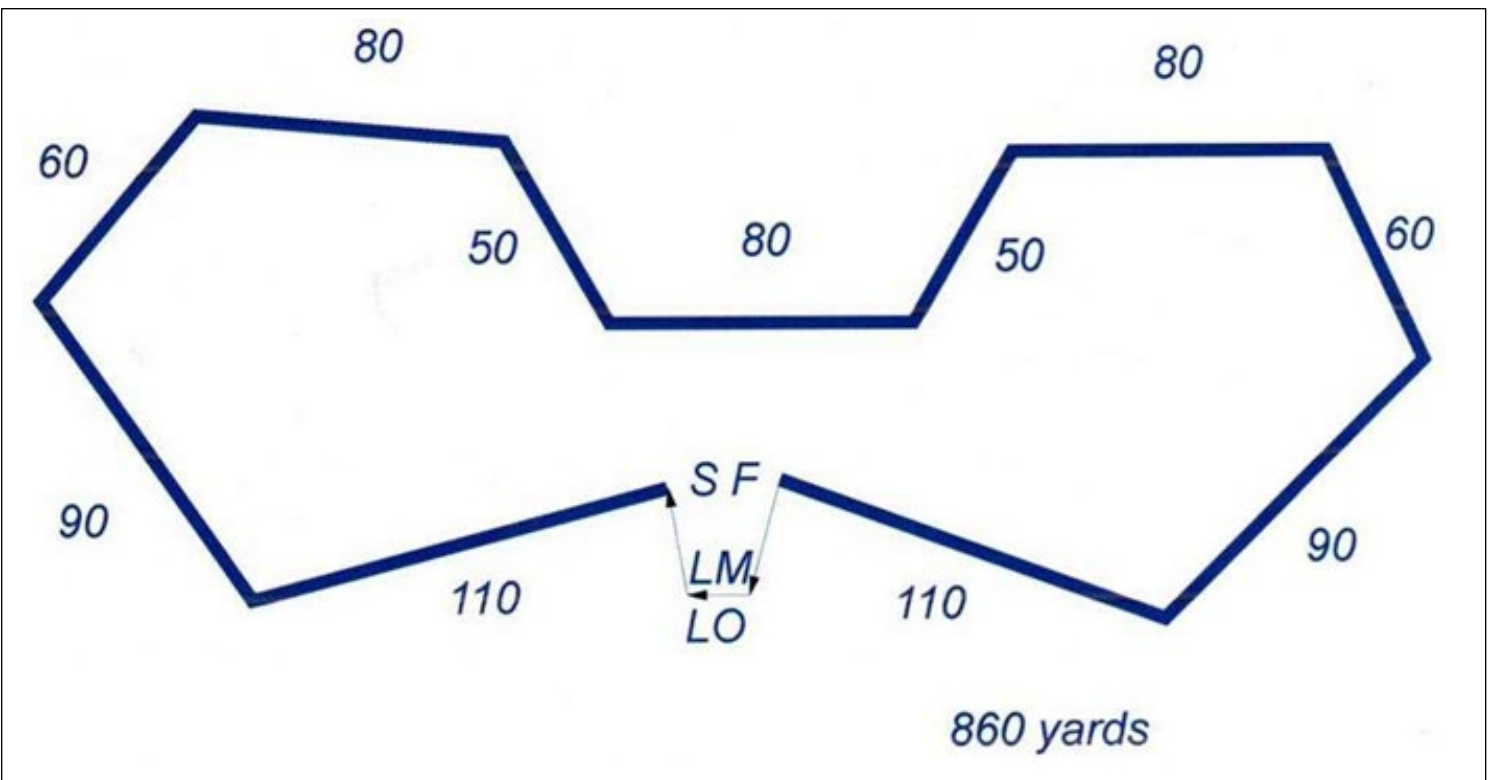
