Cuvee [Erynn Lucas] picked up both majors handily from the puppy class this summer!

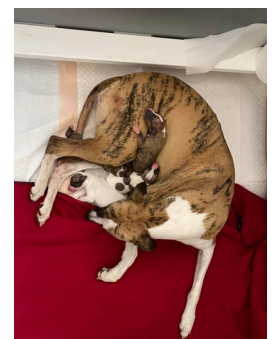

If you are not entering, you can buy lunch on the NCWFA website. Ed reported that he has procured enough plastic chain from MB-F that we can set-up a 50 by 50 size ring on site, using our own stakes. He will also be bringing the San Joaquin KC's photo podium for use as a ramp. Ed will be bringing the ring markers, as well. Cheryl, Kim, Rick & Jen volunteered to spearhead set-up on Saturday morning. All members will be helping with tear down after the show. The meeting was called to order by President Debby Knutson at 2:30 PM.

### Officer's Reports

**President's Report:** Debby thanked all for coming and staying for the meeting. She wished all well & expressed her hopes that the Delta Variant would not adversely affect any of our lives & our fall and winter events.

**Secretary's Report:** No report.

**Treasurer's Report:** Guin reported on behalf of Delia that the combined bank balance [general account & PayPal] is \$17774.97. Discussion ensued regarding the \$1200 donation listed on the report. Erynn reported that this was made to the Rescue Fund by Kim Dagan, who adopted Henley.

### Committee Reports

**Coursing:** Jen Haas reported that plans are well underway for our October 24th Whippet-Specialty trial. She is still waiting to hear back from Jayme Jones [potential judge # 2] & if she does not get a response by the end of this week, will move on to asking Lisa Voss if she is willing to judge.

Discussion ensued regarding holding JC/QCs with this event & if the QC dogs could qualify to run that day. It was decided to offer JC/QC tests at the beginning of the event, but not to allow day-of entries for those who qualify, since running in lure coursing is different than racing, and there is a concern that dogs who have only raced may QC, but not be ready to run in competition. We will be offering Singles Stake for those who are not qualified who wish to compete. Jen has asked Audrey Hsia to help with field set-up & Greg Witt to run the lure. Charlotte and Guin will be field clerks, as per usual, & Erynn Lucas will be our Huntmaster. Jen will send out information on other roles that will need filling as we get closer to the event.

**Show:** Guin reported that we are approved by the AKC & our premium list will drop at the end of August. Entries to open 9/1. She reminded all that there are classes for racing & coursing champions & also extended ages in the sweepstakes [up to 24 months]. Great prizes, including toys for all entrants. Guin will be sending out the Trophy Sponsorship info on 8/1. Debby & Kim will be in charge of the vendors & info for prospective vendors will go out by mid-August. Discussion ensued regarding if we will be able to have our traditional potluck lunch & silent auction. At this time it is unknown what the COVID restrictions will be at the time of our event. If we do not have this info by 8/30, or if the college does not loosen their protocols by then for the fall, we will be doing box lunches from Panera for all entrants & spectators that can be purchased for a nominal fee. 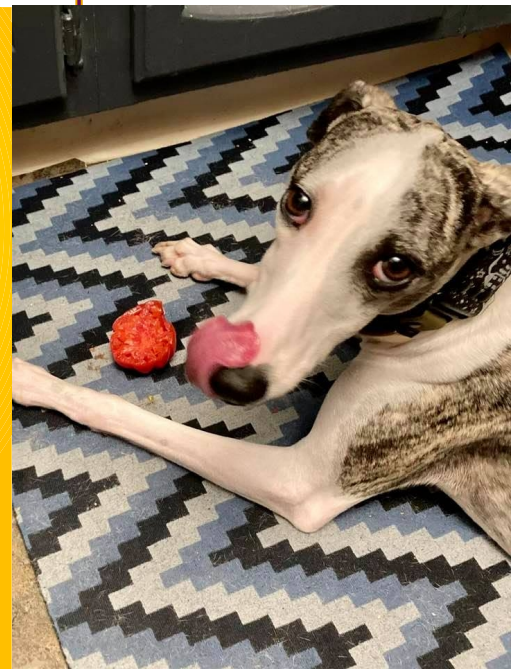
